?If driverless cars decrease car accidents by 99%, the amount I make would be hugely affected, but that?s

not why I am an attorney. I?m an attorney because I want to do my part to make the world a better place. I

see driverless cars as proof that our efforts have helped promote long-lasting change,? said attorney Tim

Ryan.

While driverless cars aim to decrease the number of accidents, injuries, and deaths on the road, their

effectiveness is still being evaluated. Driverless cars for public use are not expected to be available for

several years (2020).
