This is not true, however, and accidents on the road are often the direct result of another party's reckless driving, negligence and so on. As such, determining who is most at fault for an accident can do more than decide who insurers pay for, and this is especially important when medical bills are involved, not just the value of the property damage.

One of the main problems with seeking compensation is the fact that insurers themselves are not on the side

As such, even though they may believe they are covered given the circumstances of an accident, a victim may find their insurer disagrees.

This is why it is recommended they avoid speaking to anyone without their attorney present. Any comments shared in "good faith" may be used against them when determining how much compensation they will receive.

The same is true in other types of personal injury cases. In situations where an employee is hurt at their place of work, for instance, Napolin says it is wise to speak to an attorney as quickly as possible. A victim's first priority should be to receive medical attention (especially since this creates documentation that can be used to build their case), but they should then seek out an experienced personal injury lawyer. Under no circumstances should they speak to their employer, insurance adjusters or even their coworkers.
