In fact, so-called "low-grade" injuries, such as whiplash, can still have a sizable impact on an accident victim's life, and it can be incredibly costly for them to correct the issue in a timely manner. This is why the firm strongly encourages accident victims not to take the risk of underestimating the damage that has been done to them. "Car accidents happen so frequently that we have come to expect to be one at some point in our lives,"

notes Alexander D. Napolin of Napolin Accident Injury Lawyer Orange County. We are all familiar with the average fender-bender and so on. However, the cost of repairing such minor damage can still easily outstrip what some can comfortably afford, and this does not account for any impact on your health and well-being. If you have been in an accident, your first step should be to seek medical attention. Your second step should be to call your attorney.

Certain types of accidents can also result in far more severe injuries. Truck accidents, for instance, receive special attention due to the enormous damage they can cause, both in terms of property and bodily harm. In turn, the medical bills that arise from such incidents can be astronomical, and the firm says it is not uncommon for entire families to buckle under the weight of a single family member's hospital bills. In addition to medical bills, accidents can make it impossible for a victim to work, either temporarily or permanently. This means they are likely dependent largely on the compensation they win to survive, especially if their life has been affected so drastically that they can never make an income to support themselves again.

This is also why the firm strongly advises anyone involved in an accident to avoid speaking to an insurance adjuster without a lawyer present. A lawyer will be able to assess the full extent of the damages incurred and determine how much compensation is due under the law. Given that profits tend to be an insurer's primary consideration, they are unlikely to provide the right amount of compensation. This may prompt them to make a quick offer to the victim which is inferior to what they are truly owed for their pain, suffering and inconvenience.

An insurer may count on your ignorance of the law to make an offer that appears generous on the surface, cautions Napolin. Do not accept without consulting your lawyer. You will likely have to release your rights to any more compensation in the future in order to accept, so if it is not enough, that will make matters much harder for you. A settlement should be reflective of the impact on your life, especially if you may need medical attention or be out of work for a significant period. No matter what, talk to your Orange accident lawyer before considering any offers.
