Product liability cases in Georgia adhere to a "strict liability approach" outlined in Georgia Code 51-1-11. It means that proving manufacturer negligence is unnecessary. The claimant only needs to demonstrate that the product was defective, used as intended, and caused injury.

Medical malpractice occurs when negligence by medical professionals leads to serious injuries or death. The laws governing medical malpractice aim to protect individuals from negligent behavior by nurses, doctors, medical technicians, anesthesiologists, and others. Common causes of medical malpractice include lack of training or experience, incorrect testing or missed diagnosis, fatigue, and improper administration of anesthesia or medication.
