Even though motorcycles make up a small percentage of vehicles on the road, just 2% according to the Governor's Office of Highway Safety's (GOHS) 2019 report, those who ride them are overrepresented in the total number of all driver fatalities (21%). Motorcycle accidents are especially dangerous because they don't offer riders the same protection that most other vehicles do.

?Some of the common reasons for motorcycle accidents include reckless driving, bad traffic conditions, lane splitting, fixed objects on the road, and poor weather conditions,? says Ronnie Mabra, the founder of The Mabra Law Firm LLC. ?Moreover, on account of the risky nature of riding a motorcycle, even minor accidents can lead to catastrophic injuries such as spinal cord injuries, lower extremity injuries, internal injuries, broken bones, skull fractures, traumatic brain injuries, lacerations, road rash, scarring and disfigurement, and more.?

Apart from the bodily injuries, motorcyclists may also suffer emotional and psychological damage that saps away their mental well-being and affects their quality of life. This is also compounded by the fact that motorcyclists, due to their poor reputation, often get the short end of the stick when seeking justice in a court of law.

?Many judges and juries have an ill-conceived image of motorcyclists,? says Ronnie Mabra. ?A few bad apples give everybody who rides a motorcycle a bad rap. So, you almost always have an uphill battle to fight in court, even if you practice all the tenets of defensive driving and equip yourself with the required safety gear. So, first and foremost, you have to get an experienced personal injury attorney on your side who understands the system to build the strongest case for you.?

Motorcycle accident victims have the right to get compensated for a variety of expenses including past and future medical expenses, loss of income, disability-related costs, motorcycle repairs or replacement and other property damage, legal fees, pain and suffering, emotional damages, loss of enjoyment, loss of quality of life, and even punitive damages.

?To get the maximum compensation you are owed,? Ronnie Mabra says, ?you have to seek immediate treatment from a medical professional who understands the kind of injuries, both short-term and long-term, that an accident victim might have endured. This helps create a direct correlation between the accident and your injuries, even those that might not manifest external symptoms for months or years to come.?

According to the statute of limitations, plaintiffs usually have around two years from the date of the accident to file a lawsuit. ?Insurance companies are not your friends,? says Ronnie Mabra. ?They will try their best to discount your injuries and reduce their client?s liability, hanging you out to dry with the long-term consequences of the accident. The first settlement they offer is designed to trick you and shrug off responsibility for pennies on the dollar.
