The Fourth Amendment guarantees the right of the people to feel secure in houses, persons, papers, and effects. Thus, no unreasonable searches and seizures are allowed and no warrants can be issued unless upon probable cause, supported by oath or confirmation, and specifically describing the place to be searched, and the things or persons to be seized.
