In one case recently filed in Supreme Court Bronx County (Index # 813749/2023), a 33-year-old man was riding an electric scooter when he was unexpectedly hit by a car making a swift U-turn. The severe injury sustained was a distal radius fracture, commonly known as a fractured wrist. In another case filed in Supreme Court Bronx County (814019/2023) a 40-year-old man was a passenger on a moped when yet another car made a U-turn. The injuries he sustained were a fractured ankle and a laceration to his head. In a case recently filed in Supreme Court Queens County (Index # 713126/2023), a 23-year-old man was riding a moped when a car blatantly ran a red light and struck him. He sustained a fractured left femur shaft requiring surgery and a fractured left eye socket.

Three other recent cases involve the following serious and severe personal injuries. There was a 10-year-old boy was riding his bike when he was struck by a fast-moving moped; he sustained a fractured right tibia

requiring surgery. Additionally, there was a 40-year-old man was riding a motorized scooter when a car ran a red light and struck him; he sustained a painful fractured left ankle. Lastly, a 16-year-old boy was riding his scooter when a vehicle swerved into him; he sustained a fractured left tibia requiring surgery.

The top hazards in electric bicycle and scooter accidents involve collisions with motor vehicles. Common facts patterns include drivers who fail to stop or yield at an intersection, turn into the path of an electric bike (e-bike), change lanes without signaling, open the door of a parked car, drift onto the shoulder or bike lane, or simply drive while distracted. Defects involving curbs, potholes, metal plates, manhole covers, and other uneven surfaces create increased dangers for electric bikes and scooter riders and put them at high risk of serious injury or even death.

The most common injuries that result from electric bike and scooter accidents include traumatic head injuries, bone fractures, and in some tragic instances, fatalities. Electric bike and scooter riders who are injured by the negligence of another can recover compensation for their injuries.
