They want to advise car accident victims in Decatur to follow a number of steps after a car collision. The first step is to call emergency services because the other person may be injured and at times, even there is no apparent pain or injury, some injuries may only become evident several hours or days later. The second step is to get treated by a doctor even if there are no apparent injuries. This can provide evidence about the injury

suffered, which can be useful when filing the claim.

The third step is to get the other driver?s information and preserve the evidence of the collision. Taking photos of the scene and the vehicles may be helpful. The fourth step is to ask for important information, such as the name, address, telephone number, license plate number, and insurance firm of the other party. Such information will be needed when filing a claim with the insurance company.

The fifth step is to provide the police officer who arrives at the scene of the accident with relevant information regarding the incident. Such information will go into the police report, which may be used when filing an insurance claim. However, if the collision occurred on private property, the police have little jurisdiction. Lastly, it is advisable to hire the services of a car accident lawyer in Decatur.

Ronnie Mabra explains, ?Once you speak with your insurance company and contact The Mabra Firm, the process of a personal injury claim can begin. Initially, it starts when you file a summons, and the lawyer serves a complaint to the at-fault party. But there are a few exceptions to this, especially if multiple people are involved, resulting in a multi-vehicle accident. There is also the chance that the at-fault party is an employee who was on the job. If that is the case, your lawyer will look into whether the person has uninsured or underinsured coverage. If so, then whoever their insurance company is also served with a complaint. If the at-fault party has no insurance, you may need to file a personal injury claim with your insurance company. Most of the time, auto insurance provides you with the necessary compensation for your injuries and damages.?

There are two types of damages that may be awarded in car accident cases. These are general damages and special damages. General damages include anything that may reduce the quality of life of the accident victim, such as pain and suffering, loss of consortium, mental trauma, disfigurement, and PTSD. Special damages include damages to physical property or medical bills. These are usually easier to calculate compared to general damages.
