It is also important to get a copy of the police report because this can be used when filing an insurance claim. However, if the incident occurred on private property, the police would have little jurisdiction.

General damages are composed of the physical injuries suffered by the victim, such as pain and suffering, loss of consortium, mental trauma, disfigurement, and PTSD. Special damages include such things as damages to physical property or medical bills. Physical damages also include: motor vehicle repairs, compensation for irreplaceable items, and damaged property repairs.

It is also important for car accident victims to be aware of the statute of limitations in Georgia that provides a limit on the number of years that they can wait to file a lawsuit against someone. For filing a claim for damages or wrongful death, people have up to two years to file a claim in the State of Georgia.
