They advise those who have been arrested and accused of a crime to contact a criminal defense lawyer as soon as they are booked in jail. It is also important not to provide the authorities details aside from basic identifying information like one's name. This is vital because details stated may be used against the accused. If they insist on asking questions, it is advisable to simply request for the presence of one's lawyer. It is also advisable to be respectful and cooperate with their requests while asserting one's right to remain silent and get connected to a lawyer as soon as possible.

Chris Lewis explains, "Once you've spoken with a Dallas criminal defense lawyer, you should be booked and released in the time between your arrest and your day in court. During this time, your lawyer can help you gather evidence and build a strong defense for your case."

Felony convictions have harsh legal penalties, including years in prison and substantial fines. They also want to emphasize that even misdemeanors can have negative impacts on the lives those who get convicted.
