In a case filed in the Supreme Court, Nassau County (604044/2021) a 53-year-old man sustained fatal injuries after being struck by a car in Hempstead, New York.

A recent study suggests that New York City ranks number one as the deadliest city for pedestrians in the United States <https://getjerry.com/studies/pedestrians-face-onslaught-as-roads-grow-more-dangerous> The

study analyzed ten years of National Highway Traffic Safety Administration fatal crash data from 2011 ? 2020. The study found that pedestrian knockdown fatalities are at a four-decade high. In 2021, 273 pedestrians were killed in New York City.

Pedestrian knockdown accidents can take place in the crosswalk, on the street, on sidewalks, and in parking lots. Fortunately, not all pedestrian knockdown accidents result in fatalities. Some of the most common pedestrian knockdown injuries include the following:

- Concussions, brain injuries, traumatic brain injuries (?TBI?)
- Fractured and broken bones
- Neck, back, and spinal cord injuries
- Dental injuries
- Internal organ damage and internal bleeding
- Crushing injuries

Some of the most common causes of pedestrian knockdown accidents include the following:

- Driver inattention
- Speeding/aggressive driving
- Failing to yield the right of way to pedestrians
- Driving under the influence of alcohol or drugs
- Distracted driving
- Poor visibility due to weather or poor lighting
