comments Kenneth S. Nugent, P.C. ?We advise all our clients to do this for a number of reasons, not the least of which is their safety and well-being. When you seek professional medical care, this creates a paper trail that can be used as evidence of the impact your accident has had on you. Receiving treatment should be your top priority, for yourself as well as your case. After that, we invite you to visit our office for a consultation.?

The firm notes that their policy is to visit clients themselves in the event the latter is unable to travel. Given their commitment to the community, Kenneth S. Nugent, P.C. makes it a point to dispatch an attorney to the client when required, a service that may prove useful in several cases (such as where bed rest is mandated by the doctor). The firm typically aims to schedule this visit within two days of being notified.

Under no circumstances should anyone involved with an accident speak to an insurance adjuster or other representative until they have consulted with their lawyer. This is due to the fact that an accident victim's statement may be used against them, potentially harming their claim and reducing the compensation they will receive. Similarly, should the insurer offer to provide a settlement immediately, the firm advises victims to decline to respond without an attorney present ? a quick settlement may be used by insurers to limit the amount they ultimately have to pay out.

These strategies are not the only reason accident victims should avoid attempting to pursue a claim alone. In addition to being forced to deal with all the bureaucracy and legal hurdles without qualified assistance, they are unlikely to understand the full extent of compensation they would be entitled to under the law.

Most may proceed under the assumptions that they are only entitled to (or only need) compensation for damages suffered in the moment. This could include vehicle repairs, medical bills from recent hospital visits and so on. However, there are numerous factors that need to be considered to determine exactly how much an individual may have lost as a result of an accident.

Kenneth S. Nugent, P.C. may check whether the client is expected to need further medical assistance in the future, how long they have been unable to go to work because their only mode of transport was unavailable (or they were unable to drive), whether the injury is extensive enough that they will never be able to return to the same job and so on. All of this is necessary to build a strong case and obtain compensation that accurately reflects the harm sustained by the victim.
