hiding the origins of illegally obtained money by making it look like it came from legal sources; bribery and corruption, which means giving, offering, or receiving something of value to influence government officials, employees, or business associates; antitrust violations, which means engaging in anti-competitive practices to limit competition; environmental crimes, which involves violating environmental laws and regulations; and healthcare fraud, which involves false claims, kickbacks, or fraudulent billing in the healthcare industry.

White collar crimes can have serious repercussions, both for the individuals and the businesses that can also be prosecuted. Ryan Garry says, "Penalties for white-collar crimes in Minnesota can include fines, restitution, probation, and imprisonment, depending on the severity of the offense. If the case is prosecuted by the United States Attorney's Office in federal court, the amount of the monetary loss will dictate where the defendant ends up in the Federal Sentencing Guidelines."
