There are a number of valid reasons for filing a personal injury claim against someone who has caused the injury. The first reason is to ensure the individual who caused the harm learns a lesson. The second reason is

to see that the safety laws or regulations are modified to prevent other people from getting injured in the same manner that the victim was. For example, if a defective and dangerous fridge was the cause of the injury, the proper safety regulations need to be put in place and the defective product must be pulled out from the market. The last reason for filing a personal injury claim is to get compensated for the damages and losses suffered as a result of the accident. There are various types of accidents that can result into a personal injury case. These include: trip-and-falls/slip-and-falls, auto wrecks, construction accidents, nursing home abuse or neglect, truck wrecks, injuries from dangerous products, premises liability, motorcycle accidents, and wrongful death.

It is usually the insurance company that pays for the compensation. For example, for those who have been injured in a motor vehicle accident, it is likely the car insurance company of the at-fault driver that will pay for the damages. For those who were injured in another person's home, it is their homeowner's insurance policy that will handle the bill for medical costs and other damages.

Thus, accident victims will usually need to deal with the insurance company, and this is not always easy because insurance companies will likely give priority to their profit, which means they will try to minimize the payout. They will likely have lawyers who will fight the claim if they believe the victim's case is weak. It is therefore a good idea to partner with a personal injury lawyer from Conway Pauley & Johnson. 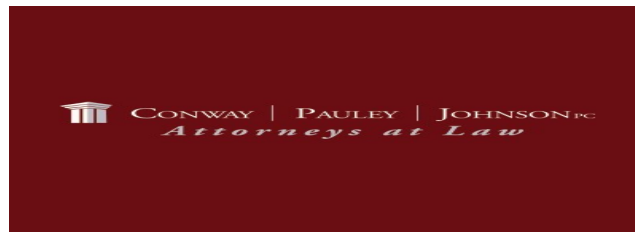
