Failure to do so will require the person on bail or the co-signer to pay the full amount of the bond. If the person out on bail misses a court date without informing anyone, an arrest warrant will likely be issued.

Meanwhile, the knowledgeable bail bond agents from Off The Hook Bail Bonds would be able to offer an insight into the legal process, helping the defendant understand their rights and how they should proceed during the trial. They can also provide support through challenging times.

In general, it will take up to 8 hours or more for the person to get released from jail once a bail has been posted with a bondsman. However, this may vary depending on the specific county and court system involved.

With regards to the cost, the spokesperson explains, "The cost associated with using a bail bondsman depends on several factors including the amount of the bond set by the court and any other fees required by the company providing services. Generally speaking, most companies charge 10-15% of the total bond amount as their fee for service."

Before posting the bond, the defendant will have to provide their name, date of birth, the address where they will be staying while out on bond (if applicable), contact information, and/or family members who may co-sign the release agreement (if applicable). Furthermore, the defendant posting bail will have to show proof that they have enough assets or financial resources to make the payment if necessary.
