App-based deliveries and ridesharing exploded onto the market in the 2010s and have since become the preferred method of transportation for a significant portion of Americans. To give context to their massive scale, from 2020 to 2021, about 1.37 million drivers performed at least one ride or delivery on DoorDash, Instacart, Lyft, or Uber. While they are lauded for their convenience and affordability, their massive popularity has also led to an increase in the number of vehicles on the road which has increased the risk of accidents for those using these services.

?There are certain risks that are inherent to the rideshare model,? says Alexander Napolin. ?For example, rideshare drivers are often constantly distracted by their phones, often juggling multiple of these apps, looking

for gigs they can complete near them. Another safety concern is speeding as the rides have to be completed within a limited time. There is also pressure to complete rides quickly to maximize one?s time working. All these behaviors are a likely cause for reckless driving. Drivers for ridesharing apps also work long hours and are prone to fatigue which impairs their judgement and reaction time. Finally, continuous use of the vehicle is also likely to degrade it faster requiring constant maintenance that might be getting overlooked.?

Alexander Napolin accident injury lawyer also highlights the many protections afforded by California law to protect rideshare users, as well as drivers, from the aforementioned risks. The coverage is broken down by periods, each representing the different stages of the process. Period 1 is when the driver has opened the app and is actively looking for customers. Period 2 is when the driver has booked a client and is on the way to their location. Finally, Period 3 is when the passenger has entered the vehicle, and it is on its way to the destination.

California provides a \$1 million aggregate bodily harm liability policy to the passengers and the driver who have been in a collision with an uninsured/underinsured motorist or for hit-and-run cases during Period 3. In a livestream on his Facebook page, Alexander shows how rideshare users can find out about the insurance limits available to them by visiting Uber?s website and viewing the documentation based on the state they are based in.

?If you have been in a rideshare auto accident,? says Alexander Napolin, ?there are some crucial steps that you need to take immediately. This includes documenting the incident, seeking medical attention, and reporting the accident to the relevant authorities. This will give attorneys who represent you a leg up in building a strong case to get you the full compensation that you are owed. Our analysis takes into consideration everything from the driver?s actions to the vehicle?s condition and adherence to traffic laws.
