Goshen, NY - In the wake of the devastating accident on the Baltimore Beltway that claimed the lives of six construction workers, construction accident attorney Brian Mittman of Markhoff & Camp; Mittman is calling for increased safety measures to better protect highway workers.

On the afternoon of May 22nd, a driver struck a vehicle before careening through a construction zone barrier and into a work crew on I-695 near Baltimore. The six workers killed were identified as Mahlon Simmons II, Mahlon Simmons III, Rolando Ruiz, Carlos Orlando Villatoro Escobar, Jose Armando Escobar, and Sybil Lee Dimaggio.

Mittman, whose firm represents construction workers injured on the job, emphasized the importance of thorough accident investigations and accountability. "The families deserve answers and justice. We have an obligation to learn from preventable tragedies like this to enact meaningful change that better values worker safety."

He urges improved safety protocols, enhanced training, better traffic control and worksite protection for those whose labor is vital to maintaining the nation's transportation arteries. "Everyone should get home safely at the end of their shift. That must be the paramount priority on every single construction project from this point forward."
