Depending on the essential oil chosen, drivers report feeling refreshed, revived, and calmed for the drive.

ScentWow features include an indicator light for high and low scent release settings, an auto shut off after one hour, and push-button reset.

AERON General Counsel Paul Gandy said the patent represents another milestone for AERON, reflecting the company?s ongoing dedication to innovation and leadership in the aromatherapy field.

Gandy also noted the patent award is a testament to the commitment of AERON?s Intellectual Property Team and the creative spirit of AERON?s ScentWow inventors. In addition to Hadley, those include AERON?s Director of Innovation Jerome Clock, Associate Vice President of Engineering and Manufacturing Patrick Guerin, and former Product Designer Ellora Hans-Price.

AERON was founded in 1996 by Hadley and business partner, Jeffrey Smith. Smith was the first person to patent an aromatherapy diffuser that operates from a vehicle?s 12-volt outlet. After securing private label retail accounts with the Power Car Fragrancer® in 2000, AERON moved into designing, engineering, and making original fragrance diffusers for national retailers, and in recent years, launched two of its own house brands.

The company?s Drive Time® brand features a line of versatile and portable USB, 12-volt and passive fragrance diffusers primarily for in-vehicle use.

Belle Aroma® is AERON?s boutique line of fragrance diffusers for home, office, vehicle and travel.
