Ten hours after being released back into police custody, he suffered a seizure that led to a severe brain injury requiring multiple surgeries, including a craniectomy. The client now resides in a nursing home with catastrophic brain damage, limited bodily control, and compromised brain function.

The jury found that the doctor departed from the standard of care by failing to order blood work and obtain an adequate medical history. They assigned 30% responsibility to the client and awarded damages for past and future pain and suffering, as well as future medical expenses and lost earnings.
