The Adult Survivors Act (ASA) previously allowed survivors of sexual offenses that occurred when they were over 18 to file civil lawsuits beyond the statute of limitations. The lookback window closed on November 24, 2023. The Gender-Motivated Violence Act (GMVA) remains open until February 28, 2025, providing survivors of gender-based violence, including coercion, intimidation, or physical force, the opportunity to file a civil lawsuit against their abuser or a complicit institution. The Child Victims Act (CVA), which allowed survivors of childhood sexual abuse to file claims beyond the standard statute of limitations, has also closed.

While some legal deadlines have passed, survivors should consult with an experienced attorney to determine if their case qualifies under existing legal frameworks. Every case is unique, and legal options may still be available depending on the nature of the abuse and when it occurred. Survivors who believe they were subjected to sexual violence that falls under the GMVA should consider taking action before the lookback window closes in early 2025.
