The lookback window for the CVA closed on August 14, 2021. However, survivors still have extended time to file civil claims compared to previous statutes of limitations.

Adult Survivors Act (ASA): The ASA provided a one-year lookback window for survivors of sexual abuse that occurred when they were over the age of 18 to file civil lawsuits. This window began on November 24, 2022, and concluded on November 23, 2023. ?

Survivors may be eligible to recover damages for medical expenses, therapy costs, emotional distress, and other hardships. Thomas Giuffra, Esq. ?
