In detail, there were 1,056 urban fatalities and 559 in rural parts. Speeding caused 349 of these deaths, while alcohol-related incidents led to 433 fatalities. Sadly, motorcyclist fatalities were 196, pedestrian deaths were 345, and there were 29 bicyclist deaths.
