It will also address the process of reporting medical sexual abuse, what legal protections are in place for survivors, and how to pursue civil lawsuits against individual healthcare providers, hospitals, clinics, and psychiatric institutions. In addition, the webinar will explain the role of medical licensing boards and regulatory agencies in disciplining abusive practitioners, as well as how financial compensation in civil cases can help survivors afford necessary medical treatment, long-term therapy, and other related damages.

Medical professionals must be held accountable when they abuse their position of trust. Survivors of Abuse NJ works to help victims take legal action against negligent hospitals, private practices, and psychiatric institutions that failed to intervene or respond properly to reports of abuse. This webinar will serve as a practical resource for survivors looking to understand their rights and learn how to begin their legal journey.

"Patients put their trust and well-being in the hands of medical professionals," said Joseph L. Messa, Esq. "When that trust is violated by sexual abuse, survivors often feel shame, confusion, and fear of speaking out. Our goal with this webinar is to empower survivors with knowledge so they understand that the law is on their side and that legal action is possible."

In New Jersey, survivors of doctor and psychiatrist sexual abuse have powerful legal tools at their disposal. The New Jersey Child Victims Act and other applicable statutes allow victims to file civil lawsuits not only against individual perpetrators but also against the institutions that allowed the abuse to continue. Survivors may also file complaints with medical licensing boards, potentially resulting in disciplinary action, license suspension or revocation, and public accountability.

By pursuing legal action, survivors can obtain financial compensation for the emotional and psychological harm they've endured, as well as for costs related to therapy and medical care. Legal action also plays a critical role in holding negligent hospitals, clinics, and institutions accountable and in preventing future abuse by exposing dangerous professionals and systemic failures.

This webinar is designed to serve a wide audience, including survivors of sexual abuse by doctors or psychiatrists, family members and loved ones seeking guidance on how to support them, and advocacy groups or professionals working with abuse survivors. It is also open to anyone seeking to better understand the legal landscape for victims of medical abuse.
