The FDA warns that, ??Consumers should not purchase or use ?Bentonite Me Baby.? Anyone who has used this product or provided it to a child should consult a health care professional immediately.?

Lead is also known to cause cancer and reproductive harm, according to Parker Waichman. Once poisoned by lead, no organ system is immune. Of particular concern is the developing brain because negative influences may have long-lasting effects and may continue well into puberty and beyond.
