Dog bite incidents represent a serious public health issue, with consequences that extend far beyond the initial injury. Victims frequently face substantial medical expenses, from emergency room visits and reconstructive surgeries to long-term physical therapy. The emotional trauma can be equally debilitating, leading to lasting anxiety, fear, and post-traumatic stress disorder (PTSD). If such a dog attacks again, the owner faces not only civil liability but also significant criminal penalties. These penalties escalate based on the severity of the injury, ranging from a class B misdemeanor for a non-serious injury to a Class E felony if a previous attack also caused serious harm. In the tragic event of a fatality, the owner could be charged with a Class D felony. The firm stressed the importance of these laws in promoting responsible pet ownership and protecting community safety.

As part of its public education efforts, Missouri Injury Law Firm is advising victims to take several critical steps following an incident. The first and most important step is to seek immediate medical attention, as even seemingly minor bites carry a high risk of infection. Documenting the incident thoroughly with photographs of the injury and the location, as well as collecting contact information from any witnesses, is also vital. Reporting the attack to local authorities, such as animal control or the police, creates an official record that is essential for any future legal action. Finally, identifying the dog and its owner is a necessary component for filing a successful claim.
