



## **As Idaho's 100 Deadliest Days Begin, Smith Law Firm Urges Drivers to Know Their Legal Rights**

Boise, Idaho ? As Idaho enters the "100 Deadliest Days," the period between Memorial Day and Labor Day known for a significant increase in traffic fatalities, Smith Law Firm is launching a public awareness campaign to educate drivers about their legal rights following accidents.

According to the Idaho Transportation Department, fatal crashes during the summer months claimed 82 lives in 2024, highlighting the heightened risks on the road during this season.

"Many drivers are unaware of the critical steps to take immediately after an accident," said Dawn Singleton, J.D., lead attorney at Smith Law Firm. "Our goal is to provide clear, accessible guidance so that drivers feel empowered, not overwhelmed." The campaign includes legal consultations and the distribution of informational materials designed to help accident victims avoid common legal missteps, such as admitting fault prematurely or accepting inadequate insurance settlements.

Despite public safety campaigns, many Idaho drivers remain uncertain about how to protect their legal rights in the immediate aftermath of a crash. One of the most common pitfalls is providing recorded statements to insurance companies without legal guidance, often leading to reduced claim values or denied coverage altogether. Smith Law Firm's attorneys stress that even minor missteps in wording can be leveraged against victims during claim evaluations, making early legal consultation a crucial protective step.

This initiative also responds to concerning local trends. According to data from the Idaho Transportation Department, the majority of summer traffic fatalities involve high-speed rural roadways and younger drivers traveling during evening hours. With many accidents occurring outside major urban centers, legal access becomes even more important. "Knowing what to do legally in the immediate aftermath of a crash can protect your health, your finances, and your future."
