?If you are young parents, you should be concerned with two things regarding yourselves: your own disability and your death,? said Chris Craig, estate planning lawyer at Craig Associates, PC. ?So whatever estate planning gets created should be addressing both of those things in a way that's substantive.?

In the article, published March 21, 2025, he speaks candidly about how most people?especially younger adults?tend to avoid estate planning simply because it?s uncomfortable to think about: ?It is likely that while they need estate planning, they don?t want estate planning,? Craig told Citizen Times.

Craig explained that any estate plan for parents should account for both short- and long-term contingencies, especially when minor children are involved. For instance, he asked, ?Does the babysitter know who to call so that DSS is never going to be involved?,? highlighting the potential consequences of not having a plan in place.

According to Craig, North Carolina has a solid legal framework that allows parents to name immediate emergency contacts as well as long-term guardians for their children. However, these designations need to be made in legally binding documents, and those named need to be informed and prepared.

?That?s really a godparent relationship in true form,? Craig said, ?because they need to feel responsible, even though they aren?t responsible. It?s a relationship building tool, and it?s also something that?s likely to change.?

Rather than treating estate planning as a one-time event, Craig encourages families to think of it as an ongoing conversation. As children grow and relationships evolve, guardianship designations and estate plans should be reviewed and adjusted accordingly.

Craig also reminds families that estate planning isn?t just about preparing for the worst?it?s also about gaining peace of mind. ?There?s a whole lot of terror that can be eliminated by having good guidance, careful guidance, with the awesome tools that are available to us,? he said.
