



## **Survivors of Abuse NY Expands Sexual Assault Survivor Resources in New York**

Survivors of Abuse NY announced the expansion of its sexual assault survivor resources aimed at providing accessible, trauma-informed information and support to individuals affected by sexual violence. The newly expanded resources include comprehensive informational materials, educational programs, and

community partnerships focused on civil remedies for survivors of sexual assault. These materials outline the steps involved in filing claims, the differences between criminal and civil proceedings, and the role of trauma-informed legal representation. By providing reliable and factual guidance, Survivors of Abuse NY aims to empower survivors to make informed decisions about their next steps without feeling pressured or overwhelmed.

Sexual assault cases can arise in a range of settings, including schools, workplaces, medical institutions, and religious organizations. Civil actions in these cases may target both individual offenders and institutions that failed to meet their obligations under state law. Courts evaluate whether organizations followed appropriate supervision and reporting procedures, responded adequately to prior complaints, and implemented policies to prevent misconduct. By pursuing these cases, survivors contribute not only to their own pursuit of justice but also to institutional reforms that strengthen future protections.

Recent legislative changes in New York have expanded the rights of survivors seeking civil redress. The Child Victims Act and the Adult Survivors Act extended the statute of limitations for filing claims and created special filing windows for cases that were previously time-barred. These laws allow survivors to bring civil actions regardless of when the abuse occurred, providing new opportunities for justice. Survivors of Abuse NY's educational programs explain these statutes in detail, outlining eligibility requirements, filing procedures, and the protections afforded under each law.

The organization's expanded resources also include trauma-informed guidance on navigating legal and emotional challenges during litigation.
