New York State has implemented laws that allow survivors of sex trafficking to pursue justice through both criminal and civil courts. The New York Human Trafficking Victims Protection and Justice Act, along with federal statutes such as the Trafficking Victims Protection Reauthorization Act (TVPRA), provides survivors with the right to bring civil claims against traffickers and those who financially benefited from trafficking activity.
