Survivors of Abuse NY investigates these matters to determine whether appropriate safeguards and compliance measures were in place at the time of the alleged abuse.

Youth athletic organizations and schools in New York are required to comply with state and federal regulations governing child protection and reporting. These include mandatory background checks, training for staff, and adherence to reporting procedures when misconduct is suspected. When institutions fail to meet these requirements, they can be found liable for negligence or for allowing an unsafe environment to persist. Courts review whether organizations fulfilled their duty of care, maintained proper supervision, and acted promptly upon receiving complaints or warning signs.
