

## Survivors of Abuse NY Addresses Title IX Sexual Abuse Cases in New York

Title IX of the Education Amendments of 1972 is a federal statute that applies to all educational programs

and activities receiving federal financial assistance. It requires schools, colleges, and universities to implement policies addressing sexual harassment, assault, and discrimination. Survivors of Abuse NY represents individuals whose rights have been violated under Title IX, including cases involving improper handling of complaints, retaliation, or failure to investigate allegations. Civil litigation may also accompany Title IX actions when survivors seek damages from institutions that failed to protect them or acted with deliberate indifference.

Educational institutions in New York are required to designate Title IX coordinators, provide training for staff, and ensure accessible reporting procedures. When schools fail to meet these standards, survivors may experience additional harm due to administrative neglect or mishandling of cases.
