Sexual abuse litigation in New York covers a broad range of circumstances involving professional, institutional, and personal misconduct. Survivors of Abuse NY represents clients in cases arising from abuse

These cases often involve claims of negligent supervision, failure to report abuse, or violations of mandatory reporting laws. Religious and community organizations have also been the subject of numerous civil abuse claims. These cases often center on whether background checks, training, and supervision were properly implemented. Civil litigation in such matters can lead to institutional changes that strengthen oversight and improve reporting systems, helping to ensure safer environments for future participants.
