



Survivors of Abuse NY Expands Access to Sexual Abuse Resources for Survivors

Survivors of Abuse NY announced an expansion of its informational resources to assist survivors of sexual abuse in understanding their civil legal rights under New York law. The initiative, based in Manhattan, reflects the organization's continuing mission to make legal information more accessible and to encourage institutional transparency in how abuse cases are reported and addressed.

?Access to accurate information is one of the most important tools survivors can have when considering their legal options,? said Thomas Giuffra, attorney at Survivors of Abuse NY. ?Our goal is to ensure that individuals understand both the protections provided under state law and the procedures involved in pursuing accountability through the civil justice system.?

The organization's expanded resources include written guides, educational webinars, and community outreach programs that explain the process of filing civil claims related to sexual abuse. These materials outline how statutes of limitation operate, how institutional liability is determined, and what remedies may be

available under current law. Survivors of Abuse NY developed the initiative to address ongoing challenges faced by individuals seeking to navigate the legal system after experiencing trauma, particularly in cases involving professional or institutional misconduct.

Sexual abuse claims frequently arise from circumstances involving schools, medical providers, religious organizations, or other entities where authority and trust play central roles. In such cases, the legal process extends beyond identifying individual wrongdoing to examining whether institutions met their obligations to prevent, report, and respond to misconduct. Civil courts often assess whether organizations fulfilled their duty of care, maintained appropriate supervision policies, and complied with state-mandated reporting requirements. When violations are identified, legal action can result not only in compensation for survivors but also in systemic reforms that strengthen oversight and safeguard future participants.

New York's legislative framework has evolved substantially to support survivors' rights. The Child Victims Act (CVA) and the Adult Survivors Act (ASA) both extended time limits for filing claims, enabling individuals who were previously unable to pursue justice due to expired statutes of limitation to bring forward their cases. These reforms have allowed survivors to seek recognition of the harm they experienced and to hold institutions accountable for past failures in oversight. Survivors of Abuse NY's newly expanded resources include detailed explanations of these statutes, clarifying who qualifies under each act and how claims are initiated.

In addition to legislative updates, the organization's materials provide information about trauma-informed legal representation, an approach that emphasizes sensitivity and respect for survivor autonomy. Survivors of Abuse NY encourages open communication throughout each stage of the legal process, ensuring that clients retain control over decisions regarding their cases. The firm's attorneys and professional staff work collaboratively with mental health professionals, investigators, and support organizations to promote a comprehensive understanding of both legal and emotional recovery.

Educational outreach remains a central component of the initiative.
