

## Survivors of Abuse PA Launches Initiative on Legal Rights for Daycare Sexual Abuse Survivors

Survivors of Abuse PA has announced a statewide educational initiative focused on raising awareness about civil legal options for survivors of sexual abuse in daycare and early childhood settings throughout Pennsylvania. The effort, led by managing attorney Ashley DiLiberto, Esq., aims to provide accurate, accessible information about how civil law can be used to hold individuals and institutions accountable for misconduct involving minors in childcare environments.

?Parents and guardians place immense trust in daycare providers to safeguard children?s well-being,? said Ashley DiLiberto, Esq., managing attorney at Survivors of Abuse PA. ?Our goal is to ensure that survivors and their families understand the civil remedies available under Pennsylvania law when that trust is violated.?

The initiative reflects growing public concern about accountability in childcare institutions, where power imbalances and lack of oversight can increase the risk of misconduct. Daycare sexual abuse cases often involve multiple layers of responsibility, including individual offenders and the facilities that employed or

supervised them. Civil claims in these cases may address failures in background checks, training, supervision, and mandatory reporting. Courts assess whether childcare providers met state licensing requirements and took appropriate action when complaints or warning signs arose.

Recent changes in Pennsylvania?s civil law have expanded survivors? access to the courts. Legislative discussions and judicial rulings over the past several years have emphasized the importance of recognizing delayed disclosure in child sexual abuse cases. Survivors of Abuse PA provides educational materials explaining how these legal frameworks operate, including statutes of limitations, notice requirements, and evidentiary standards applicable to abuse claims.

Through its outreach program, Survivors of Abuse PA seeks to equip survivors and families with a clear understanding of their rights and the steps involved in civil litigation. These materials explain how claims are filed, what documentation may be required, and the potential outcomes of legal proceedings. By emphasizing procedural transparency, the organization aims to empower survivors to make informed decisions about whether to pursue civil action.

Daycare abuse cases can involve complex institutional relationships, such as corporate ownership structures or third-party management companies. Legal claims may extend beyond individual employees to include entities responsible for oversight and compliance with childcare safety regulations. Evidence in such cases may consist of internal communication records, inspection reports, and employee files that reveal whether appropriate preventive measures were implemented. Survivors of Abuse PA?s initiative highlights how these factors contribute to establishing negligence or institutional liability in civil court.

The organization also promotes trauma-informed advocacy as a central component of effective legal representation. Many survivors of early childhood abuse experience long-term emotional and psychological effects that can complicate participation in legal processes. Survivors of Abuse PA emphasizes a model that respects survivor autonomy, confidentiality, and emotional well-being, while maintaining clarity about procedural rights and responsibilities. This approach is designed to balance the legal complexities of civil litigation with sensitivity to the unique challenges survivors face.

Broader conversations about child safety in Pennsylvania?s daycare system continue to evolve among policymakers, legal professionals, and child welfare organizations. Civil litigation has contributed to significant reforms, including stricter background check protocols, enhanced staff training, and improved communication between agencies responsible for licensing and enforcement. By addressing both individual accountability and institutional reform, Survivors of Abuse PA contributes to ongoing statewide efforts to strengthen child protection in early education and childcare environments.
