"Many rideshare passengers assume they are automatically covered by the rideshare company's insurance policy, but the reality is far more complex," said a firm representative. "The applicable insurance coverage depends on multiple factors, including the driver's status at the time of the accident, whether other vehicles were involved, and the specific circumstances of the collision."

The three-tier insurance system for rideshare drivers operates as follows: When drivers are offline and using

their vehicles for personal use, only their personal auto insurance applies. When drivers are logged into the app but have not accepted a ride request, limited liability coverage from the rideshare company supplements the driver's personal insurance. When drivers have accepted a ride request or are transporting passengers, the rideshare company's commercial insurance policy provides primary coverage.

This tiered structure often creates coverage gaps that leave passengers uncertain about their compensation options. Additionally, disputes frequently arise between personal insurers and rideshare company insurers about which policy should respond to a claim.

For passengers injured in rideshare accidents, documentation becomes crucial. The firm recommends immediately recording the driver's name, the trip details from the app, photographing the accident scene, obtaining witness information, and seeking prompt medical attention even for seemingly minor injuries. Screenshots of the ride status and fare information can prove essential when establishing which insurance tier applies.

These situations may involve the rideshare driver, another motorist, the rideshare company, or even vehicle manufacturers in cases involving mechanical failures.
