Georgia's comparative negligence law allows accident victims to recover damages even when partially at

fault, yet many drivers remain unaware of this protection. The state's minimum insurance requirement of \$25,000 per person often proves inadequate for serious injuries, leaving victims with substantial uncovered expenses. Additionally, Georgia's fault-based insurance system means the at-fault driver's insurance company bears responsibility for damages, creating an adversarial relationship from the start.

The firm emphasizes that insurance companies routinely offer initial settlements far below a claim's actual value, knowing most people lack the knowledge to evaluate their case properly. This practice particularly affects victims unaware of Georgia's two-year statute of limitations for personal injury lawsuits, which can pressure them into accepting inadequate compensation.

Intersection accidents present unique challenges due to conflicting accounts of events, multiple potential liable parties, and complex traffic law violations. The recent spike in Johns Creek intersection accidents underscores the importance of understanding proper post-accident procedures and legal rights.
