Cultural factors also play a significant role in settlement disparities. Many Hispanic families come from countries where the legal system operates differently, leading to mistrust or misunderstanding of the American legal process. Some families face pressure from within their communities to accept quick settlements rather than pursue lengthy legal proceedings.
