"Construction workers are being forced into impossible situations where they must choose between their health and their livelihood," said David Benn, a representative for WorkInjuryRights.com. "We're seeing employers threaten job loss if workers don't return within arbitrary timeframes, insurance companies using so-called independent medical examinations to declare workers fit for duty against their treating physician's advice, and companies creating fake light-duty positions just to cut off disability benefits."

Common pressure tactics identified by the firm include surveillance investigators monitoring injured workers' daily activities, premature termination of temporary disability benefits, and offering modified duty assignments that exceed medical restrictions. These practices violate Florida laws protecting injured workers from employer retaliation, yet enforcement remains challenging without legal representation.

The WorkInjuryRights.com workers compensation attorney team has successfully challenged these practices, securing proper medical treatment and fair compensation for injured construction workers. The firm emphasizes that Florida's two-year statute of limitations for most workers' compensation claims makes early legal consultation critical for protecting workers' rights.

Re-injury rates among construction workers who return to work prematurely are substantially higher than those who receive complete medical treatment and appropriate recovery time. The long-term costs of permanent disability far exceed the short-term savings employers and insurance companies seek through rushed return-to-work programs.

The firm notes that Florida's "one-time change" rule, which allows injured workers only one physician change during their entire claim, makes initial medical care decisions particularly crucial. When combined with employer-selected physicians and independent medical examinations that can override treating doctor restrictions, injured workers face systemic challenges in receiving appropriate care.
