Under current Thai law, foreign nationals cannot own land directly but may purchase condominium units or enter into leasehold agreements. The standard lease term remains limited to 30 years under the Civil and Commercial Code, with recent court decisions invalidating automatic renewal clauses that attempt to extend beyond this period. This ruling has significant implications for thousands of existing property arrangements throughout Thailand.

"Foreign investors need to understand that Thailand's property laws are designed to protect national interests while still allowing international participation in the market," said Omar O. Manee, Head of Property Division at Siam Legal Phuket. "The recent Supreme Court decision on lease renewals underscores why professional legal guidance is essential before committing to any property transaction in Thailand."

The Thai government has proposed extending lease terms from 30 to 99 years to attract more foreign investment, though these reforms await legislative approval. Additionally, the Board of Investment will implement stricter rules on land ownership privileges for foreign businesses starting September 2025, potentially affecting corporate property holding structures commonly used by international investors.
