The National Safety Council found, in their latest release, that more than 120,000 people were hurt in truck accidents between 2021 and 2023. This includes UPS truck accidents. These numbers are higher than those from more recent years, as it's a leap of more than 2% since 2021 alone.

Big Ben Lawyers have represented victims of multiple kinds of truck accidents. A recent client received compensation for an accident where they were struck from behind by a commercial vehicle while waiting to turn.

In all cases the firm handles, a personal injury attorney from Big Ben Lawyers identifies any and all parties

may be liable for injuries their client suffered. This even includes those who were partially liable. Then, Big Ben and his team bring a lawsuit against all even partially liable entities.

Often, the UPS truck driver is the liable party. However, there can be other liable parties. For example, if the truck was poorly maintained and this directly led to the accident, then those responsible could be liable. The same applies to those who loaded the truck.

The firm investigates every clients? case. By doing so, they?re able to not just identify the liable parties but also to determine the extent to which they were liable.

Big Ben and his team also sit down with every UPS truck accident client to discuss the potential compensation for which they may be eligible. In the State of California, this compensation can take two forms.

An accident involving a UPS truck can cause a significant amount of pain and suffering for the victim. Many victims find that their quality of life has diminished in the wake of a truck accident. Truck accident victims can receive compensation for their pain, their suffering, their loss of enjoyment of life, and more. This is referred to as ?non-economic? compensation.

If the victim?s injuries necessitate medical treatment, the victim may be able to receive compensation. Referred to as ?economic compensation,? this form of compensation can cover rehabilitation, their medication, time in the hospital, physical therapy, and much more. Jury Verdicts Publications, (previously "Jury Verdicts Research,") analyzed jury verdicts in 20 years of truck accident cases. They found that, approximately 60% of the time, the victim received damages in a lawsuit. However, a higher majority of these cases settle outside of court.
