Florida law permits employers to select treating physicians, which can complicate the determination process. Insurance companies may pressure doctors to declare maximum medical improvement prematurely, particularly when temporary disability benefits approach their statutory limits. With temporary total disability benefits capped at \$1,018 per week as of 2024, financial pressures mount for injured workers awaiting this crucial determination.

Construction workers face particular challenges given the physical demands of their occupation. Returning to work after reaching maximum medical improvement but before achieving functional recovery can result in re-injury or permanent disability. The firm reports increasing cases where workers suffered preventable permanent injuries due to premature return-to-work mandates following hasty determinations.

"Understanding the medical and legal aspects of maximum medical improvement empowers injured workers to make informed decisions about their treatment and compensation," added Benn. "Workers should document their ongoing symptoms and functional limitations, especially as they approach this critical juncture in their recovery."
