



## **Horst Shewmaker, LLC Augusta Secures \$35,650 Settlement for Rear-End Accident Victims Including Three Minors**

The case involved a mother who was transporting her two children and their friend to school when another driver struck their vehicle from behind.

The collision occurred when the client slowed for traffic ahead, and the following vehicle failed to maintain a safe distance, resulting in a disabling impact to the at-fault driver's vehicle. The responding officer cited the other driver for causing the rear-end collision, establishing clear liability in the case.

The mother suffered injuries to her back, neck, shoulders, and stomach, requiring immediate hospital treatment followed by ongoing conservative care with a chiropractor. The three minors in the vehicle also sustained injuries requiring medical evaluation by pediatricians, with two of the children needing additional conservative treatment during their recovery.

Horst Shewmaker's legal team methodically documented all medical treatments and associated costs for each victim. Through strategic negotiations with the at-fault driver's insurance carrier, the firm secured individual settlements tailored to each victim's specific injuries and treatment needs. The mother received \$19,500 in compensation, while the three minors received settlements of \$11,100, \$3,900, and \$1,150 respectively, reflecting the varying degrees of injury and medical care required.

"This case exemplifies why families need experienced and caring car accident attorneys who understand the complexities of multi-victim collisions," said Michael Horst, founding attorney at Horst Shewmaker, LLC Augusta. "When children are involved in accidents, the stakes become even higher. Insurance companies often attempt to minimize settlements, particularly for younger victims whose long-term effects may not be immediately apparent. The successful resolution of this case highlights the importance of thorough documentation and persistent advocacy in rear-end collision cases.
