The initiative comes as the region approaches the one-year anniversary of the devastating January 2024 ice storm that caused unprecedented damage to homes and infrastructure across the Portland metro area.

The January 2024 ice storm, which lasted days with temperatures remaining below freezing for consecutive days, resulted in extensive property damage throughout Lane County and the greater Portland region. According to the National Center for Environmental Information, Oregon experienced in the most recent five-year period (2020-2024) an average of 2.0 such events per year. The 2024 ice storm alone toppled more than 20,000 trees in Springfield and left 75% of Springfield Utility Board customers without power at some point during the event.

The National Roofing Contractors Association (NRCA) recommends routine roof inspections and maintenance twice annually, typically in spring and fall, to identify potential issues before they become costly problems. The organization's snow remediation hazard analysis indicates that a cubic foot of snow may weigh between 10 and 30 pounds, with loads imposed on buildings by snow accumulation potentially reaching critical limits that could result in partial or complete structural collapse.

According to the Oregon Construction Contractors Board, all contractors performing construction work for compensation in Oregon must maintain proper licensing, bonding, and insurance. Tonys Roofing holds the required Oregon CCB license and maintains full bonding and insurance coverage, as verified by the Better Business Bureau. The company's accreditation status demonstrates compliance with BBB Standards for Trust following comprehensive vetting processes.

The Occupational Safety and Health Administration emphasizes the importance of winter weather preparation for construction workers, noting that cold weather, strong winds, and slippery surfaces create dangerous health risks. OSHA's winter weather resources recommend that employers implement comprehensive safety measures when workers must perform roofing activities during challenging weather conditions.

Oregon's residential building codes, as outlined in Chapter 9 of the Oregon Residential Specialty Code, establish specific requirements for roof assemblies and materials compatibility. The codes mandate that roof assemblies must be constructed of materials compatible with each other and with the building structure, with specific provisions for areas experiencing severe weather conditions.

The free inspection program addresses growing concerns about insurance coverage for aging roofs. Industry reports indicate that insurance companies are increasingly scrutinizing roof conditions, with many carriers now requiring inspections or replacement of roofs older than 15 years. Roof-related insurance claims have reached all-time highs according to industry analyses, making proactive maintenance and inspection critical for homeowners.
