The intersection of cannabis tourism and DUI law requires specialized knowledge that addresses both the immediate legal concerns and the long-term interstate implications."

The firm has observed that many visitors are unaware that Colorado law enforcement uses different testing methods and impairment standards than their home states. Blood tests for THC metabolites can show positive results days or weeks after consumption, creating challenges in proving actual impairment at the time of driving. Additionally, field sobriety tests designed primarily for alcohol impairment may not accurately assess cannabis-related impairment.

Understanding these distinctions and the potential consequences is essential for anyone visiting our state."
