"After years of educating and training hundreds of the top newborn care specialists in the industry, we recognized a critical gap in the market," said Sakowicz. "Many families were hiring caregivers through social media referrals, unvetted brokers, or agencies with minimal screening standards. Parents deserve better? they deserve access to specialists who have completed rigorous, accredited training and have been thoroughly vetted for safety, competency, and professionalism."

The decision to expand from education into placement services stemmed from this identified need. By maintaining direct relationships with specialists who completed the agency's CACHE-accredited training program, The Newborn Care Solutions Agency ensures quality control that other agencies cannot match.

CACHE International, which stands for Council for Awards in Care, Health and Education, represents the gold standard in newborn care accreditation. Unlike self-certification programs or weekend workshops, CACHE accreditation requires comprehensive curriculum covering evidence-based infant care, safe sleep practices aligned with AAP guidelines, infant feeding and lactation support, postpartum recovery and maternal mental health, family dynamics and professional boundaries, and emergency protocols including infant CPR and first aid.

"CACHE accreditation isn't something you can buy or fast-track," Sakowicz said. "It requires rigorous curriculum development, external auditing, ongoing assessment, and annual compliance reviews. We're proud to offer the only CACHE-accredited newborn care training program in the United States, and that credential directly benefits the families we serve."

Sakowicz's tenure with the International Nanny Association, including service as co-president and board member, provided deep insight into the professional childcare industry's challenges, opportunities, and best practices. The INA, founded in 1985, is a nonprofit educational association for nannies, caregivers, and industry professionals.

"My time with the INA reinforced the critical importance of proper vetting, professional boundaries, and ethical placement practices," Sakowicz said. "I saw too many situations where families or caregivers were harmed by unethical practices or inadequate screening. Those experiences directly influenced how we built The NCS Agency?with transparency, ethics, and quality as non-negotiables."

What distinguishes The Newborn Care Solutions Agency from competitors is its direct pipeline from comprehensive education to professional placement. This model provides quality control through direct relationships with specialists who completed the founder's training program, ensuring consistent standards

and shared philosophy around evidence-based care. Specialists receive regular updates on evolving best practices and professional development opportunities through the agency's educational arm.

When The NCS Agency matches a family with a specialist, staff members often personally trained that specialist. Many agencies rely on caregiver-provided documentation that can be easily falsified. The Newborn Care Solutions Agency uses third-party specialty companies for comprehensive criminal background screening, personally verifies references and credentials, conducts in-depth interviews assessing both technical knowledge and emotional intelligence, and administers proprietary skills assessments covering safe sleep, feeding, and emergency protocols.

The widespread misuse of terms like baby nurse and night nurse creates confusion and can lead families to hire underqualified caregivers. The NCS Agency actively educates families about proper terminology, the difference between various types of postpartum support, what qualifications to look for, and why accurate terminology matters for ensuring qualified care.

Some agencies charge families high hourly rates while paying specialists low wages. The Newborn Care Solutions Agency operates through a transparent placement fee model, allowing specialists to receive fair compensation while families avoid inflated costs from agencies extracting ongoing hourly fees.

"The postpartum period is too important?and families are too vulnerable?for us to accept substandard care as the norm," Sakowicz said. "Every family deserves access to qualified, compassionate, professional support during those critical early weeks. That's not just our business model?it's our mission."

The agency's reputation has earned trust from diverse clientele including first-time parents seeking expert guidance, high-net-worth families requiring premium discreet service, families with complex needs such as multiples or preemies, working professionals needing flexible reliable support, and families who have experienced fertility challenges or loss.
