The program draws guidance from industry standards outlined by the Tree Care Industry Association (TCIA), which emphasizes that professional emergency response requires specialized training, equipment, and personnel coordination. Parshall Tree Care Experts' crews are trained in hazard identification, structural assessment, and safe removal procedures in line with TCIA protocols and Michigan Department of Natural Resources (DNR) recommendations.?

**Key Program Features:** The Emergency Response Program includes comprehensive hazard assessment conducted by ISA-certified arborists who evaluate structural integrity, degree of damage, and risk level to determine appropriate mitigation strategies. Personnel utilize advanced equipment and personal protective gear to safely address immediate threats while adhering to all local, state, and federal safety regulations.

The program prioritizes emergency situations based on risk level, addressing first those trees posing immediate threats to human life, critical infrastructure, and property?consistent with post-storm response guidelines established by the Rhode Island Department of Environmental Management. Secondary priorities include trees affecting traffic flow and those located in lower-risk areas.?

Safety is a top concern, according to guidance from the Michigan Department of Natural Resources. The agency specifically recommends that professionals handle trees and limbs near power lines, noting that downed utility lines or trees leaning on lines should be reported to utility companies or emergency services. Parshall Tree Care Experts coordinates directly with local utilities and emergency services to ensure all necessary precautions are implemented during removal operations.?

Michigan's 2025 storm season has highlighted the critical need for professional emergency tree services. Recent ice storms and severe thunderstorms resulted in widespread tree damage across Northern Michigan, with Governor Gretchen Whitmer declaring states of emergency in multiple counties. The Michigan Department of Natural Resources documented numerous instances where immediate professional assessment prevented additional property damage and ensured public safety.?
