"The new hands-free law represents a significant shift in how South Carolina addresses distracted driving and provides accident victims with stronger legal protections," stated J. Olin McDougall, II, founding partner at McDougall Law Firm. "When this law takes effect, victims injured by distracted drivers will have clearer legal grounds for pursuing compensation, as violations of the statute can serve as evidence of negligence in personal injury cases."

The legislation creates specific prohibitions against handling mobile devices while operating a vehicle, with exceptions only for emergencies and certain hands-free operations. For accident victims, this means that police reports documenting hands-free violations can become crucial evidence in insurance negotiations and potential litigation. The firm emphasizes that proper documentation following an accident becomes even more critical under the new legal framework.

Accident victims who suspect distracted driving contributed to their collision should take immediate steps to protect their rights. This includes obtaining witness statements, requesting police reports that note potential device usage, and preserving any available video evidence from traffic cameras or dashcams. Insurance companies may adjust their claim evaluation processes in response to the new law, potentially affecting settlement negotiations.

The timing of legal representation also matters for those injured in crashes involving distracted drivers.
