For misdemeanor convictions, expungement may be possible after three to five years. Non-specified felonies generally require a three-year waiting period following sentence completion, while specified felonies involving force, controlled substances, or weapons necessitate a five-year period after probation or incarceration. A petition to the circuit court must demonstrate the individual's rehabilitation and confirm that they pose no risk to public safety.

Even after successful state-level restoration, federal restrictions under 18 U.S.C. § 922(g) may persist, requiring additional steps to address. The Law Offices of Barton Morris manages both state and federal dimensions of these cases, ensuring thorough handling from assessment to resolution.

Barton Morris, principal attorney at The Law Offices of Barton Morris and Michigan's only Forensic Lawyer-Scientist designated by the American Chemical Society, explained the platform's purpose. "ArmedAgain.com offers a centralized source for news, updates, and practical tools like the eligibility calculator to assist individuals in determining if they may qualify for federal firearm rights restoration," said Morris.
