substantial evidence of acquired distinctiveness to maintain exclusive rights."

Companies across California face mounting challenges in distinguishing their products and services while maintaining enforceable trademark rights.

The risk extends beyond initial registration difficulties. Historical examples include former trademarks like escalator, aspirin, and thermos, which lost protection after becoming generic terms in everyday language.

"Businesses need to understand that trademark protection exists on a spectrum," explained Jafari. "Fanciful and arbitrary marks receive the strongest protection, while descriptive marks require additional proof of secondary meaning. This means showing that consumers associate the mark specifically with your company, not just with the product description."

The firm recommends several strategies for businesses currently using or considering descriptive trademarks. These include developing strong branding campaigns to establish secondary meaning, maintaining detailed records of marketing efforts and consumer recognition, and considering supplementary arbitrary or fanciful elements to strengthen overall brand protection.

For existing businesses with descriptive marks, the firm advises conducting regular trademark audits to assess vulnerability levels and implementing proactive enforcement strategies to prevent dilution. Documentation of advertising expenditures, sales figures, and consumer surveys can prove invaluable if trademark rights are challenged.
