Today, Corvettes from this generation remain in strong demand among collectors, partly due to their combination of performance potential and historical significance. Many automotive historians regard the C2 models as a turning point for Chevrolet, bridging the gap between classic 1950s styling and the higher-performance focus that would define later generations.
